



# European Citizens' Panel on Energy Efficiency

Summary of Session 3

# [12-14 April, 2024]





## In a few words...

The third and final session of the European Citizens' Panel on Energy Efficiency gathered around 150 participants from across the EU in Brussels on 12-14 April. The weekend was dedicated to debating and finalising the citizens' recommendations.

Thanks to their hard work, the citizens adopted 13 recommendations largely covering three sectorial topics (buildings, transports, and energy infrastructure) and three overarching questions (social justice, EU in a global economy and addressing the interests of different actors). Following a ballot vote, the final recommendations were handed to Maroš Šefčovič, Executive Vice President of the European Commission in charge of the Green Deal, Interinstitutional Relations and Foresight.

#### What happens now?

The citizens' recommendations are expected to feed into the design of future Commission initiatives, notably a Commission proposal for a Recommendations on the Energy Efficiency First Principle, due later in the year.

# What can we learn from this last session?

#### Day 1: Recap of the previous session, feedback from the Knowledge Committee, and preparation of the working groups

On Friday, citizens gathered in plenary to discuss with the members of the Knowledge Committee, returning to the remit question, "How can the EU prioritise Energy Efficiency and bring its full benefits to citizens, public authorities and enterprises?".

At the start of the session, Paula Pinho, **Director for the Just Transition, Consumers, Energy Security, Efficiency and Innovation, at DG ENERGY,** provided feedback on the draft recommendations developed by the citizens, with an emphasis on putting energy efficiency first. In her words: "This European Citizens' Panel has taken us on amazing journey; it was new for you, but also for us. The possibility to get input directly from citizens on EU energy efficiency policy has been both welcome and insightful. Your recommendations focus on themes that we want to solve: energy prices, social justice, energy communities, and



prices, social justice, energy communities, and transport, At the same time, you have brought a new and refreshing perspective."

Members of the Knowledge Committee then commented on the draft recommendations:

Reinhard Six, Independent Consultant and expert on energy efficiency financing: "When we talk about the primacy of energy efficiency, we need to invest in fields that will reduce energy consumption. How can all this be financed in a way that is profitable for investors (property owners, public authorities, companies)?"



Arianna Vitali, Secretary general, The Coalition for Energy Savings: "There are two recommendations in the field of transport. Energy for transport represents 30% of the energy consumed in Europe. Our mobility choices have a direct influence on our energy consumption, we need to be sure we prioritise public and private electric transports."

Efficiency Policy and Financing, DG ENER, "Quite a few recommendations focus on the local level, for example on energy communities, and this is very valuable as it gave us direct insight into people's experiences 'on the ground'."

During the afternoon, citizens were divided into two sub-plenaries to discuss the draft recommendations and exchange reflections.

#### Day 2: Finalising the recommendations

On the Saturday, citizens worked in 12 groups to finalise their recommendations. The session began with a discussion on Friday's sessions and set the focus for the day ahead. Each group designated an "ambassador" to present the outcome of the initial discussions on the group's recommendation, connecting them with a similar or related draft.

During the second part of the session, participants addressed key questions required to finalise their recommendations:

- Why is this recommendation important to you?
- What trade-offs are you willing to live with?
- How does it contribute to energy efficiency and how can it help to integrate the "Energy Efficiency First" principle in decision-making?
- What will change in Europe if this recommendation is implemented?
- What are the changes to your life and the life of your community?

Knowledge Committee members were on hand to respond to respond to remaining uncertainties in the form of written, or in-person, questions. The end of the day focused on refining the body text of the recommendations (title, explanation, justification) to ensure clarity and precision. Facilitators ensured consensus within the groups.

#### Day 3: Presentation and voting of the final recommendations

On Sunday, the citizens were back in plenary to present and vote on the final 13 recommendations. Citizens voted on each recommendation using a scale from 1 to 6 to express their strength of support.

The votes were counted in the presence of citizen observers to ensure transparency. They were personally presented by the oldest panellist, Antanas, and the youngest panellist, Martina, to **Executive Vice President Maroš Šefčovič**.

**Executive Vice President Maroš Šefčovič** thanked the 150 citizens for their participation, dedication and hard work **since February**.

To conclude this European Citizens' Panel,



Richard Kuehnel, Director for Representations and Communication in Member States at European Commission (DG COMM), thanked citizens for their engagement and dedication during these three sessions, "My colleagues at DG ENER have been impressed by your work, your recommendations, which are highly focused. You've become experts both in energy, and in democracy. We'll be publishing a report to respond to your recommendations, and we'll keep in touch with you."
